RESOLUTION

WHEREAS, pursuant to Idaho Code §31-870, Bannock County may impose and collect fees for those services provided by the County which would otherwise be funded by ad valorem tax revenues; and

WHEREAS, Idaho Code §§11-729, 31-875, 31-3203, 31, 3904 and 31-4404 further allow county commissioners to impose and collect fees; and

WHEREAS, user fees supplement tax revenues and allow for costs to be recovered by those receiving the service; and

WHEREAS, notice of a public hearing for regarding fee increases and the imposition of new fees was published in the Idaho State Journal, pursuant to Idaho Code §63-1311A, on September 5 and 12, 2021; and


WHEREAS, the Board of County Commissioners have examined the proposed fees and have determined that such fees should be set to meet expenses of operation, maintenance, repairs and other appropriate charges for operation and upkeep of for each department; and

NOW, THEREFORE, BE IT RESOLVED that the fee schedules that follow are hereby adopted, effective October 1, 2021.



Civil Process Fees - I.C. §31-3202

Detail	Current Fee
For serving summons and complaint, or any other process by which an action or proceeding is commenced, on each defendant	\$50.00
For serving a subpoena, for each witness summoned	\$50.00
For serving every notice, rule or order	\$50.00
For serving a writ of execution where a levy is NOT made on personal property each address	\$50.00
For serving a writ of execution where a levy IS made on personal property <i>for</i> cash demand or till-tap <i>only</i>	\$50.00
For serving an attachment on property, levying an execution, executing an order of arrest, or order for the delivery of personal property each address <i>*towing and storage additional</i>	\$100.00 minimum + actual costs
For serving a warrant of distraint	\$50.00
For serving a wage or financial institution garnishment service of financial institution requires an additional separate fee as noted	\$50.00 (*Separate \$7.00 check made to bank required)
Interim returns	\$5.00
Service of writs of foreclosures or orders of sales on real property	\$300.00
Posting sale notices	\$10.00 each
