

The Bannock County Search and Rescue is a professional volunteer organization within the Division of Emergency Services under the authority of the Bannock County Sheriff and is bound by policies and procedures of that office and the county of Bannock, Idaho.

Formed in the early 1960's, to fulfill the Sheriff's responsibility for search and rescue, the unit has undergone many changes and assumed numerous duties and responsibilities. As well as performing it's foremost mission of Search and Rescue, the unit now provides:

- Extrication services at traffic accidents, industrial, and farm-related accidents
- Traffic control assistance to area law enforcement agencies
- Non-transport medical services, in support of conventional and airborne ambulance services.
- Emergency and disaster-related assistance to adjacent jurisdictions as authorized by the Sheriff.

The membership process begins with an initial background check. Prospective members then serve a probationary period during which training and/or certification is obtained in areas that include:

- Incident Command System
- Emergency Vehicle Operation
- Traffic Control Familiarization
- Helicopter Landing Zone Certification
- Extrication Certification
- CPR/AED Certification and Basic First Aid
- Advanced First Aid or EMT-B Certification
- Ground and Airborne Search Techniques



Bannock County Sheriff's Search and Rescue is an all-volunteer organization that is administered and organized under the office of the Bannock County Sheriff. The purpose and primary mission of this group is to provide emergency services for Bannock County. Members are expected to adhere to the guidelines and policies as outlined in the "General Policy Manual for the Bannock County Sheriff's Search and Rescue". Members are also expected to train and maintain a skill level in search, rescue, extrication, medical certification, and other courses of instruction which are required to fulfill the mission and goals of the group.

Before your application can be considered for Probationary Membership, a background check will be conducted which includes your past driving record and convictions. The information received from this check will have a direct bearing on your acceptance.

You should be aware that a certain financial responsibility goes along with membership in this unit. You will be expected to assume the responsibility of installing lights, group-owned radios and other equipment as may be deemed necessary to perform your duties. Each member must furnish his own vehicle, insurance and upkeep, with a small compensation for your fuel costs. You will be expected to pay for half of your uniform cost; the other half will be paid by the unit. This can amount to a certain financial burden that we wish to make any prospective member aware of in advance.

Our unit is made up entirely of volunteers, and while we are not paid, we are nonetheless professionals and conduct ourselves as such. We each share in the pride of our unit's excellent performance to the citizens of Bannock County.
