
WHEREAS, Idaho Court Administrative Rule (“ICAR”) 62(d) allows the judge assigned to a case or the Administrative District Judge to develop a supplemental voir dire questionnaire to address questions for prospective jurors; and,

WHEREAS, the Honorable Rick Carnaroli finds that all counties in the Sixth Judicial District have need to utilize a supplemental voir dire questionnaire when qualifying jurors for reasons including, but not limited to, providing additional information for the parties and the Court that may expedite the voir dire process.

IT IS HEREBY ORDERED:

1. Pursuant to ICAR 62(d), all counties in the Sixth Judicial District shall utilize the Supplemental Voir Dire Questionnaire attached to this Order or other supplemental voir dire questionnaire approved by the judge assigned to the case; and,
2. The Supplemental Voir Dire Questionnaire shall be used prospectively by the Jury Commissioners in each county, beginning with the next jury term of service that the Jury Commissioner has to qualify.
