Community Service Project Waiver of Liability

Juveniles assigned to Community Service Project will be expected to comply with the following Rules and Dress Code.

Juvenile will:

1. Arrive at the assigned location on time and ready to work.
2. Not leave early without prior arrangement with the Program Coordinators.
3. Not be under the influence or possess any drugs, alcohol, tobacco, or drug paraphernalia.
4. Not bring friends to Community Service
5. Not use foul language or discuss crimes.
6. Not possess lighters or any weapons.
7. Have no physical contact "Horse Play" with other juveniles.
8. Understand that laziness or insubordination will qualify loss of Community Service Hours.
9. Understand that disrespect to the Community Service Coordinators will result in a Probation Violation.
10. Comply with the Dress Code.
11. Be held to the Exhibit A Rules and Conditions of Probations.
12. Not damage the vehicle transporting juveniles to/from community service. Juveniles will be required to pay restitution for any damage to Bannock County vehicles/property while at community service. This includes poking holes in seats, writing on seats, breaking equipment, etcetera.

Dress Code:

1. Do Not wear gang related clothing. This includes sagging pants, hats worn on the side, and shirts deemed inappropriate.
2. Do Not wear clothing advertising alcohol, tobacco, or drugs.
3. Do Not wear short shorts, skirts, belly shirts, spaghetti straps, low cut shirts, or other clothing deemed inappropriate by the Community Service Coordinators. **T-shirts, knee length shorts, capris, and jeans are appropriate work attire.**
4. Do Not wear opened toed shoes.
5. **Dress ready to work outside; long sleeves, jackets, hats, and gloves.**

I, (Parent or Guardian) _____, agree to assume liability for any damage to property caused by my child at any of the locations Community Service is performed; including damage to the vehicle transporting my child to and from community service. In addition, I agree to release Bannock County and all facilities where Community Service is performed from liability for damage or injury to my child or my child's property. I also agree that in an emergency, if medical care or surgery, including the administration of an anesthetic, is needed for said Child, and it appears from competent medical advice that delay in giving such care will be harmful to said child and the undersigned cannot be reached or located in time to sign personal consent, this document will constitute an official consent for such medical care or surgery by a regularly licensed physician, at any time when the above child is under the supervision of the Juvenile Probation Department staff, up to the age eighteen (18), unless such consent is revoked in writing.
