 BANNOCK AND CARIBOU COUNTIES, STATE OF IDAHO

The purposes for which the proposed levy revenues will be used and the approximate amount of levy funds to be allocated to each use are as follows:

Purpose	Approximate Amount Allocated
Curriculum (Updating, aligning and maintaining curriculum to state standards)	\$540,000
Special Populations (Assisting needs of special populations that are underfunded by state and federal funds)	\$240,000
Extracurricular/Co-curricular (Maintaining and supporting current programs including athletics, arts and scholastic teams)	\$232,700
Classified Staff (Funding, to include compensation, of existing necessary support staff not funded by the state, including classroom aides, library aides, custodial services, bus drivers and food service workers)	\$477,300
Total	\$1,490,000

QUESTION: Shall the Board of Trustees of Marsh Valley Jt. School District #21, Bannock and Caribou Counties, Idaho, be authorized and empowered to levy a Supplemental Levy in the amount of One Million Four Hundred Ninety Thousand Dollars (\$1,490,000) per year for two (2) years, commencing with the fiscal year beginning July 1, 2026 and ending on June 30, 2028, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on August 25, 2025.

The estimated average annual cost to the taxpayer on the proposed Supplemental Levy is a tax of \$62.74 per \$100,000 of taxable assessed value, per year, based on current conditions. If the proposed levy is approved, the tax per \$100,000 of taxable assessed value is expected to increase by \$62.74 per \$100,000 of taxable assessed value.
