RE: ORDER PROHIBITING
COMMENCEMENT OF JURY TRIALS IN
CERTAIN COUNTIES IN THE SIXTH
JUDICIAL DISTRICT OCTOBER 19
THROUGH OCTOBER 23, 2020

ADMINISTRATIVE ORDER
2020-24

WHEREAS on October 8, 2020, the Idaho Supreme Court issued its Order entitled “In Re: Jury Trials,” the provisions of which govern the conduct of jury trials in Idaho (“Jury Trial Order”); and,

WHEREAS on September 10, 2020, the Idaho Supreme Court issued a further Order regarding Jury Trials entitled “Re: Commencement of Jury Trials” (“Jury Trial Commencement Order”) that requires the Administrative District Judge to review the Cases by County page of the Idaho Department of Health and Welfare’s COVID-19 Data Dashboard (Dashboard) each week to determine if criminal jury trials may proceed for a particular county for a given week; and,

WHEREAS Section 4 of the same Jury Trial Commencement Order permits the Administrative District Judge to exercise discretion to enter an order, in writing and containing a factual basis, to prohibit the commencement of jury trials where there are circumstances beyond the incident rates which pose a substantial increase in the health or safety risks to jury trial participants; and,

WHEREAS the Administrative District Judge has determined upon review of the Dashboard that a discrepancy exists between confirmed and probable cases reported by the Southeastern Idaho Public Health District for the counties in the Sixth Judicial District and the confirmed and probable cases reported on the Dashboard for those same counties; and,


WHEREAS the Administrative District Judge finds this discrepancy impacts the 7 day moving average incidence rate per 100,000 population displayed on the Dashboard for the counties in the Sixth Judicial District in a way that poses a substantial increase in the health or safety risks to jury trial participants because it does not reflect the confirmed and probable cases reported by the Southeastern Idaho Health District; and,

WHEREAS calculation of the 7 day moving average incidence rate per 100,000 population for certain counties in the Sixth Judicial District based upon confirmed and probable cases reported by the Southeastern Idaho Public Health District do not meet the standards regarding 7 day moving average incidence rates per 100,000 population set in Section 3(a) or 3(b) of the Jury Trial Commencement Order to resume jury trials.

IT IS HEREBY ORDERED that the following Counties of the Sixth Judicial District **SHALL NOT** conduct jury trials for the week of October 19-October 23, 2020 and that any jury trial set to proceed during that time frame in those counties shall be vacated and reset:

Bannock County
Caribou County
Franklin County
Oneida County
Power County

Southeastern Idaho Public Health has 168 new confirmed cases of COVID-19 (69 in Bannock County, 2 in Bear Lake County, 52 in Bingham County, 1 in Butte County, 15 in Caribou County, 19 in Franklin County, 4 in Oneida County and 6 in Power County) in southeast Idaho. 102 New COVID-19 Cases Identified in Southeastern Idaho

Starting today, Southeastern Idaho Public Health will be reporting the probable case counts for each county along with confirmed cases in their daily press releases. As a reminder, probable cases are individuals that have had contact to a confirmed case and are experiencing symptoms, but have not been tested or it is a symptomatic individual that has tested positive with an antigen test.

Southeastern Idaho Public Health has 102 new confirmed and probable cases of COVID-19 in southeast Idaho. This brings the total of confirmed and probable cases to 4,181. Out of the 4,181 cases, 3,329 have recovered from COVID-19. See county case counts below:
